# (Department of Information Technology) NOTIFICATION

New Delhi, the 16<sup>th</sup> March, 2012

- **G.S.R. 153(E).-**In exercise of the powers conferred by sub-section (2) of section 79 of the Information Technology Act, 2000 (21 of 2000) read with sub-rule(4) of rule 3 of the Information Technology (Guidelines for Cyber Cafe) Rules, 2011, the Central Government hereby specifies the process of registration to be followed by each Registration Agency as follows:-
- 1. The Cyber cafe shall, for its registration, submit the duly filled in form as specified in Schedule-I annexed, to the Registration Agency notified by the Appropriate Government.
- 2. The Registration Agency shall, after verifying the completeness of the form, register the cyber cafe with a unique registration number. The registration number shall be an alphnumeric code of eight characters with first two characters as the State or Union Territory code as specified in Schedule-II annexed and next six digits as running serial number. For instance, a cyber cafe registered in Maharashtra may have registration number as MH001234.
- 3. The list of cyber cafe alongwith its address and registration number shall be displayed on the website of the Registration Agency.
