- 3.1 <u>Means of Finance</u>: Confirmed Means of Finance to be provided by the applicant along with the final application.
- 4. This "In-Principle" approval constitutes of an "In-Principle" approval to apply for a formal approval for setting up a Greenfield EMC as per the EMC Scheme Notification and Guidelines. Upon receipt of application for final approval and its due consideration by the Competent Authority that all requirements with respect to the Scheme have been satisfactorily complied, a final approval will be issued including sanction for projects approved for financial support that will be available for the said project(s). This "Inprinciple approval in itself does not construe any obligation on Government to the said project(s)
- 5. The applicant needs to fulfill the following requirements by the time of submission of final application:
  - 5.1 **Anchor Unit:** The Applicant should identify an Anchor unit for the EMC and provide the details for the same. The Anchor unit should propose to set up a unit in EMC engaged in the manufacturing of electronic products.
  - 5.2 **Environmental clearances:** The Applicant should obtain Environmental Clearance from Tamil Nadu State Environmental Impact Assessment Authority followed by Consent to Establishment from Tamil Nadu State Pollution Control Board.
  - 5.3 **Power and Water Supply:** The Applicant shall provide confirmation of power availability/ supply from Tamil Nadu Electricity Board and Permission/ MoU for supply of water from New Tirupur Area Development Corporation Ltd. (NTADC) and/or permission/clearance from Ground Water Board/ concerned Authority for abstraction of ground water.
  - 5.4 Road connectivity for landlocked area: The Applicant should provide road connectivity for any land area not acquired by the Applicant by final application stage but which gets landlocked within the EMC area.
