- 3. This "In-Principle" approval constitutes of an "In-Principle" approval to apply for a formal approval for setting up a Greenfield EMC as per the EMC Scheme Notification and Guidelines. Upon receipt of application for final approval and its due consideration by the Competent Authority that all requirements with respect to the Scheme have been satisfactorily complied, a final approval will be issued including sanction for projects approved for financial support that will be available for the said project(s). This "In-Principle approval in itself does not construe any obligation on Government to the said project(s).
- 4. The applicant should fulfill the following requirements by the time of submission of final application:
 - 4.1 Land ownership and land Use: At the time of final application, the applicant should submit required documents in accordance with the EMC Scheme/Guidelines showing the land is in possession of the applicant and use of the proposed land is industrial.
 - **4.2 Anchor Unit:** The Applicant should identify an Anchor unit for the EMC and provide the details for the same. The Anchor unit should propose to set up a unit in EMC engaged in the manufacturing of electronic products.
 - **4.3 Detailed Project Report:** The applicant should submit a detailed project report as per the EMC Scheme/ Guidelines along with complete Bill of Material, Cost estimates, Time lines, Implementation schedule, etc. along with the final application.
 - **4.4 Audited Financial Statement:** The applicant shall submit the audited financial statements of financial year 2014-15 along with the final application.
 - **4.5 Revenue Model:** In the final DPR, the applicant should provide Revenue Model with realistic assumptions consistent with implementation plan.
 - **4.6 Environmental Impact Assessment:** The applicant shall provide necessary documentation for compliance to all applicable environmental regulations as applicable.
 - 4.7 Power and Water Supply: The applicant shall provide confirmation of power availability/ supply from concerned Electricity Board/ Authority and Permission/ MoU for supply of water from concerned Area Development Corporation and/ or

- permission/clearance from Ground Water Board/ concerned Authority for abstraction of ground water (as applicable).
- **4.8 Memorandum of Association:** The existing Memorandum of Association (MoA) should be modified to include setting up of infrastructure projects/ industrial parks/ manufacturing clusters as one of the objectives of the applicant company.
- **4.9 Financial Closure:** The applicant should submit confirmed means of finance for meeting the project requirements.
