2. Joint Secretary (eGov), DeitY, welcomed all the participants and discussed the current implementation status of eDistrict MMP. The key decisions and actions to be taken are listed below:

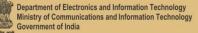




