# Subject: Minutes of Meeting of the eDistrict MMP National Rollout Project held on 13<sup>th</sup> October 2014 via Video Conferencing with the States/UTs

A meeting was held on 13<sup>th</sup> October 2014 to review the State readiness for the launch of eDistrict Services in the current financial year as per the RFD targets for FY14-15 and specific issues that State/UT are facing to accomplish the same. The meeting was conducted under the chairmanship of Dr. Rajendra Kumar, Joint Secretary (eGov), DeitY through Video conferencing from 4:30 pm in the Conference Room, 4<sup>th</sup> Floor, Electronics Niketan, New Delhi. The list of officials who participated in the meeting is placed at Annexure A. A copy of the presentation that was discussed during the Project Review Meeting is placed at Annexure B.

2. Joint Secretary (eGov), DeitY, welcomed all participants and discussed the current implementation status of eDistrict MMP. Joint Secretary (eGov) highlighted that the launch of eDistrict services by the States have been delayed and the States need to expedite the implementation process to meet the targets. The key decisions and actions to be taken are listed below:


