Subject: Minutes of Meeting to review the progress of eDistrict MMP and Integration of eDistrict application with Centralized MobileApp held on 09th June 2015 through Video Conferencing with the States -Assam, Manipur, Mizoram and Chhattisgarh.

A meeting was held on 9th June 2015 to review the progress of eDistrict MMP in the states and integration of eDistrict Application with Centralized MobileApp developed by NIC. The meeting was conducted through video conferencing from 2:30 pm in the Conference Room No 4009, Electronics Niketan, DeitY, New Delhi. The list of participants in the meeting is placed at Annexure A.

2. Director (eGov), DeitY, welcomed all participants and discussed the current implementation status of eDistrict MMP. The States were requested to complete the following activities and submit the timelines of the same to DeitY.

- a) All the states to submit the time-lines by 15th June 2015 for launch of all services in the portfolio.
- b) States to ensure the compliance to the final architecture specified in Integrated Framework guidelines and availability of data sets on open data platform.
- c) States to ensure that the service delivery channels – CSCs, Portal, etc. are clearly specified in the GOs along with service charges and also share the copy of Government Orders (GOs) issued.
- d) States to ensure the submission of UCs at the earliest to enable DeitY to release the funds to the States under e-District MMP subject to the allocation of funds for e-District project in this financial year.
- e) State of Assam to submit the timelines for go live of e-District Services in remaining districts.
- f) In response to above, the State of Assam conveyed that the e-District services in the remaining 6 non-pilot districts will be launched by 31st July 2015. Further,

launch of all the services in the portfolio will be done in phased manner and timelines for the same will be shared with DeitY by 15th June 2015.

g) State of Chhattisgarh to submit the timelines for hiring of e-District Project Managers in remaining 3 districts by 15th June 2015.

3. In the meeting, NIC apprised about the National eDistrict Portal developed by them. Subsequently, NIC team showcased the features of eDistrict Portal and process related to upload of project related documents using the Contributor ID. Additional features of verifying State-wise Services Portfolio list and checking the status of service application on the eDistrict Portal was also demonstrated.

4. Further, the NIC team also presented the centralized MobileApp features to the States and requested cooperation from the States to integrate their eDistrict Application with Centralized MobileApp.

5. It was emphasized that the integration between eDistrict Application and centralized MobileApp may be completed in 1-2 weeks' time. In this regard States are requested to share the details of the State's Technical lead of eDistrict application so that the integration with MobileApp can be initiated at the earliest and completed by 20th June 2015. The details can be mailed to eDistrict-mmp@nic.in and eDistrict-dit@nic.in.

6. NIC was also requested to share the user manuals and technical documents with the States related to the eDistrict portal and integration of eDistrict application with the centralized MobileApp. It was informed that the same will be circulated with the minutes and also it will be uploaded on the DeitY website.

7. Representatives from the State of Assam suggested that a centralized application may be developed by NIC for verification of the certificates issued by the States. It was informed that this verification module has already been implemented in the State. The State was requested to share the details of this verification module so that NIC team can study and plan for its development.

The meeting concluded with vote of thanks to and from the chair.
