In continuation of the Notification No:36(3)/2012-IPHW dated 21<sup>st</sup> March 2013 regarding notifying Brownfield Clusters, now renamed as "**Notified Electronics Manufacturing Clusters for the purpose of MSIPS**" (as cited at reference 5 above) under the M-SIPS scheme in Electronics Systems Design and Manufacturing (ESDM) sector, a supplementary list of areas "Notified Electronics Manufacturing Clusters for the purpose of MSIPS in the Union Territory of Dadra & Nagar Haveli is placed at Annexure-1 to this notification. These Notified Electronics Manufacturing Clusters for the purpose of M-SIPS are generic in nature and include all verticals of ESDM.

2. All units within these area which are located within industrial estates or an area approved by state/ central /local government or municipal authorities for use of industrial purpose will be eligible for M-SIPS benefits.

3. Separate projects for assistance under the EMC scheme can be prepared and applications made for different verticals in these notified areas. These applications would be considered in accordance with the EMC Scheme referred to as reference 4 above.
4. The Department of Electronics and Information Technology (DeitY) may issue supplementary list of "Notified Electronics Manufacturing Clusters for the purpose of MSIPS or amend existing list of Notified Electronics Manufacturing Clusters for the purpose of M-SIPS, as required in the best interest of the M-SIPS and EMC schemes.
5. The Number of "Notified Electronics Manufacturing Clusters for the purpose of MSIPS mentioned in this notification will change as per the application (s) received for different areas across India from time to time till the validity of M-SIPS scheme.
6. Any other area(s) across India qualifying for notification as "Notified Electronics Manufacturing Clusters for the purpose of MSIPS as per Para 4 of the guidelines for identification and notification of the Brownfield Electronic Manufacturing Clusters Now renamed as Guidelines for notifying Electronics Manufacturing Clusters for the purpose of M-SIPS cited as reference 3 above, will be identified and added to the list of Notified Electronics Manufacturing Clusters for the purpose of M-SIPS of this notification on ongoing basis.
7. This Notification comes into effect immediately.
