Notifying Brownfield Clusters under M-SIPS scheme in the Electronics Systems Design and Manufacturing (ESDM) Sector

Reference:

- 1. Modified Special Incentive Package Scheme (M-SIPS) Notification No.175 dated 27<sup>th</sup> July2012 in Part-I, Section 1 of the Gazette of India (Extraordinary) [F.No.24 (10) –IPHW]
- 2. M-SIPS Guidelines issued for operationalization of the M-SIPS dated  $7^{th}$  October 2012 [File no. 27(3)/2012-IPHW]
- 3. Guidelines related to identification and notification of Brownfield Electronic Manufacturing Clusters for M-SIPS dated January 14, 2013 [F.N. 36(3)/2012-IPHW]
- 4. Electronics Manufacturing Scheme (EMC Scheme) Notification No 252 dated 22<sup>nd</sup> October 2012 in Part-1, Section of the Gazette of India (Extraordinary) [F.No: 8(50)2011-IPHW]

The Government has notified the Modified Special Incentive Package Scheme (M-SIPS) to provide fiscal incentives to Electronics System Design and Manufacturing (ESDM) units located in Electronic Manufacturing Clusters (EMC) in India vide Notification No.175 dated 27<sup>th</sup>July 2012 in Part-I, Section 1 of the Gazette of India (Extraordinary) [F.No.24(10)–IPHW], hereinafter referred to as the 'Scheme', Thereafter, the detailed guidelines were issued for operationalization of the said scheme on 7<sup>th</sup> October 2012 [File no. 27(3)/2012-IPHW], hereinafter referred to as the 'M-SIPS Guidelines'

- 2. Para 5.3 of the Scheme provides that assistance under the scheme will be available to the units setup within Electronic Manufacturing Clusters (EMC's) to be notified by the Department of Electronics and Information Technology.
- 3. Further, Clause 3.9 of the M-SIPS Guidelines also provides that Department of Electronics and Information Technology will issue separate guidelines for notification of Brownfield EMCs. The said guidelines have been issued vide reference 3 cited above.
- 4. In furtherance of the Scheme vide clause 5.3 of the M-SIPS Guidelines related to Identification of the Brownfield Electronic Manufacturing Clusters for M-SIPS, Department of Electronics and Information Technology (DeitY) hereby notifies that the Electronics Manufacturing areas listed at Annexure-1 of this notification are identified and notified as Brownfield Electronics Manufacturing Clusters for the purpose of MSIPS scheme.

- 5. A list of notified Brownfield Electronics Manufacturing Clusters for the purpose of M-SIPS scheme is placed as Annexure-1 to this notification. These Brownfield EMC's are generic in nature and include all verticals of ESDM.
- 6. All units within these areas which are located within industrial estates or an area approved by state/ central/ local government or municipal authorities for use of industrial purpose will be eligible for MSIPS benefits.
- 7. Separate projects for assistance under the EMC Scheme can be prepared and application made for different verticals in these notified Brownfield EMC's. These applications would be considered in accordance with the EMC scheme referred to as reference 4 above and guidelines issued thereafter.
- 8. The Department of Electronics and Information Technology (DeitY) may issue supplementary list of Brownfield EMC's or amend existing list of Brownfield clusters as required in the best interest of the M-SIPS & EMC schemes.
- 9. The Number of Notified Brownfield clusters mentioned in this notification will change as per the application (s) received for different areas across India from time to time till the validity of the MSIPS scheme.
- 10. Any other area/s across India qualifying for notification as Brownfield Electronics Manufacturing Clusters as per para 4 of the Brownfield Electronics Manufacturing guidelines will be identified and added to the list of Notified Brownfield EMC's of this notification on ongoing basis.
- 11. This Notification comes into effect immediately.
