- 3. In supersession of the Office Order No. 33(3)/2013-IPHW(Vol.III)(Pt.3) dated 12.06.2014 (copy enclosed at Annexure-III) regarding handling of complaints pertaining to the policy for providing preference to domestically manufactured electronic products in Government procurement, it has been decided that STQC may continue to handle complaints pertaining to the aforesaid notified Electronic Products as per Para 9 (Verification of local content/ Domestic Value Addition) of the Electronic Products Notification No. 33(1)/2017-IPHW dated 14.09.2017.
- The following STQC laboratories: ERTL(North), ERTL(West), ERTL(East), and 4. ETDC(Bangalore) are designated as nodal laboratories and the respective Senior Director of the aforesaid laboratories is designated as the Nodal Officer for handling of complaints. Further, DG, STQC has been designated as appellate for complaints against laboratories.
