

- 1. The State-wide rollouts of the eDistrict MMP across the country are at various stages of implementation. Some States / UTs have already selected their System Integrators (SI) through tendering process or through nomination process. A meeting through video conferencing was held on 28<sup>th</sup> January 2014 at 11.00 AM in the PMU Conference Room, 4<sup>th</sup> Floor, Electronics Niketan, New Delhi under the chairmanship of Sh. Gaurav Dwivedi, Director (eGov), DeitY to review the project with the States / UTs were SI Selection is yet to be completed. The list of officials who participated in the meeting is placed at Annexure A.
- 2. Sh. Gaurav Dwivedi, Director (eGov) informed the current status to the States /UTs with regard to the key project milestones such as DeGS formation, DPM Hiring, SPMU Selection, Apex Committee Approvals, SI RFP, SI Selection and Roll out of eDistrict Services in the districts (presentation on current project status is placed at Annexure B).
